I realize that we have been pushing to ensure that this ARP process goes to council in June, but we are only prepared to participate (and contribute to funding) in this process if we believe it is a transparent, open and collaborative process aimed at achieving the goals of the MDP, CTP, Plan It, etc. while including all stakeholders.

As per Brian's email last week regarding the detailed information you sent out to the SSASP members, we are very concerned with a few items. Most specifically, we have no idea why the CA would be engaged directly without any involvement from the land owner (February 28 CA meeting). As we have mentioned several times, we feel that the president of the University Heights Community association (and specifically a couple other community association members) DO NOT represent the greater sentiment from surrounding communities and stakeholder groups. They simply have one agenda which is to reduce the density of potential development allowable under the current zoning.

From the beginning of this process over two years ago, we agreed with the City that it would be "collaborative". This will be the third time now (see email below from UHCA President) that we have requested to be present at a meeting including the community specifically regarding the development of land that we own and have been told that we were not welcome.

We are specifically requesting that this be addressed immediately and that we, as the land owner, are able to be represented at any stakeholder meetings to ensure that our position is communicated appropriately.

Des, I understand that you have a difficult position trying to balance all of the stakeholder requests regarding this site. That said, we are the owner and developer - too much weight is being given to one stakeholder (and specifically a couple of people) in this process.
