Hi Carmen,

Please see below for a draft response for Rollin to provide to Mr Khu. We consulted with Trudy Wobeser (Law) and identified that a brief and contained response is the best way forward to minimize legal and communications risk. Please note that answers to most, if not all of the questions raised by Mr Khu have already been provided to him and the public through the project website (FAQ), multiple emails, by telephone, and in person.

In review with Law, we have confirmed that we will be in a strong position to respond to the concerns raised with respect to land use designation, the status of the South Shaganappi Communities Area Plan, parks and municipal reserve issues, and overall engagement and project management.

Please let us know if this meets Rollin's expectations for a response to this letter. If he would like more detail, we can certainly provide it, and are happy to meet or otherwise discuss this further.

Dear Mr Khu,

Thank you kindly for taking the time to articulate your concerns with respect to the Stadium Shopping Centre Area Redevelopment Plan (ARP) project. Your comments will be fully considered as we continue to move forward with the timeline agreed upon by Alderman Hodges and the University Heights Community Association, and will be included as part of the attachments to reports to both the Calgary Planning Commission and City Council.

The revised timeline anticipates a June 6 date for the Calgary Planning Commission and a July 22 date for a Public Hearing of City Council. Please note that Calgary Planning Commission meetings are open to the public, and you can submit further comments prior to the meeting, however the public cannot speak at the meeting. Members of the public are encouraged to participate in public hearings of City Council.
